## MODULE 4

### Resilient Leadership and Agile Networking in a Global Multidisciplinary Ecosystem

Format: Onsite

Duration: 3 days per event

Timeline: September 2025 to December 2027

*A certificate of attendance will be granted during the Global Leadership Summit and World Real Estate Congress. To attain the FIABCI Designation, candidates must participate in at least one Summit and one Congress within two consecutive years after joining the Designation program. Attendance at global events requires separate registration through each host chapter.*



# FIABCI DESIGNATION

## RECOGNITION

Upon fulfilling all the aforementioned requirements, designees will receive an official Designation Certificate and a special pin, in addition to individual certificates for each module. Designees are authorized to use their designation in email signatures, social media, and other relevant communications. They will also be listed on the FIABCI Website, displaying their photograph, full name, and designation status (active/inactive/revoked).

## DESIGNATION ENHANCEMENT PROGRAM

**Maintaining an active Designation status requires:**

- Renewal of membership with FIABCI
- Attendance of at least two FIABCI Global events within each three-year term after obtaining the designation
- Failure to meet these requirements will result in the deactivation of the designation status, and the designee cannot use the title in any communication.

## REVOCATION OF DESIGNATION

**The designation may be revoked in the following cases:**

- Exclusion/expulsion from FIABCI
- Conviction for unethical behaviour such as fraud, corruption, or human rights abuses
- Being subject to international sanctions or blacklisting due to involvement in activities considered harmful to international peace, security, or human rights
- Having criminal convictions and/or convictions related to serious crimes

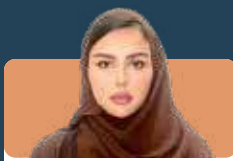

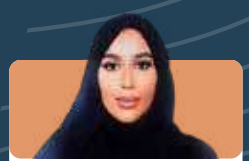

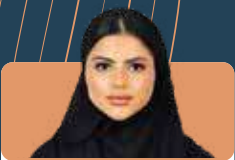
